

Privacy Policy of GoPix

Your privacy is important to GoPix. Our Privacy Policy covers how we collect, use, disclose, transfer, and store your information and customized user data. We hope our policy is straightforward and easy-to-understand. If you do not accept the content of the following terms, we are unable to provide service for you.

Please take a few minutes to review the details of our privacy practices below. By using the GoPix service, you acknowledge and agree that you have consented to the collection, use, disclosure, transfer and storage practices set out in this Privacy Policy. Particularly, if you are under 18 years old, you shall read these terms under the guidance of your parent or legal guardian, and you shall use GoPix only after your guardian agrees to these terms.

1. Definition

1.1 “GoPix” is our application name and it can also refer to the legal entity that develops and provides GoPix service, i.e. Nanjing 9Broad Technology Co., Ltd., hereinafter referred to as “GoPix”, “we”, “us” or “our”.

1.2 “Personal Information” refers to all kinds of information recorded by electronic or other means that can track back to the identity of a specific individual or reflect the activities of a specific individual independently or in combination with other information.

1.3 “Non-Personal Information” refers to the processed anonymous user information that cannot identify specific individuals and cannot be recovered, such as data that does not allow direct association with any specific individual.

2. Non-Personal Information

We may collect Non-Personal Information via third-party analytics SDK. Such information is collected and used for purposes of statistics, trouble-shooting, bug-fixing and improvement of user experience. Currently, GoPix applies analytics SDK from two providers: Firebase and Flurry.

3. Personal Information

No Personal Information is collected, stored, transferred or disclosed by GoPix service.

4. User Data Protection

Though GoPix application asks for access to user’s photos for purpose of performing the service, they are all accessed and processed locally, which means no photo or other user data is transmitted or stored at server end.

5. Enforcement

We regularly review our own compliance with our Privacy Policy. If you submit a formal written complaint, we will contact you and try our best to resolve the issue.

6. Changes

Our Privacy Policy may change occasionally. We will not reduce your rights under this Privacy Policy without providing explicit, advanced notice. We will post any privacy policy changes on this page and, in the event of significant changes, we will provide a more prominent notice (such as an email notification).

7. Governing Law & Dispute Resolution

7.1 Governing Law

The formation, execution, validity, interpretation and performance and the settlement of disputes concerning this Privacy Policy shall be governed by and construed in accordance with the laws of the People's Republic of China, without giving effect to any conflict of law principles.

7.2 Dispute Resolution

7.2.1 Except as otherwise agreed between you and GoPix, claim or controversy arising out of or relating to this Privacy Policy or the breach, termination, enforcement, interpretation or validity of these terms (collectively, "Disputes") shall be settled by lawsuits.

7.2.2 You agree that Disputes between you and GoPix will be resolved by binding, individual lawsuit and you waive your right to participate in a class-action lawsuit.

7.2.3 Unless you and GoPix both otherwise agree, the lawsuit shall be under the jurisdiction of a People's Court in Chengdu City, Sichuan Province, People's Republic of China. GoPix shall not be liable for any legal fees and/or other costs incurred prior to receiving complete notification of the claim.

8. Compliance with Laws in Other Jurisdictions

If you are residing in other countries/jurisdictions, we will make our best effort for you to exercise your rights pursuant to your local data privacy legislation, so far as it's not in conflict with applicable laws of the People's Republic of China.
